1. Complete the application found on the reverse side of this notice IN FULL.
2. Provide a copy of your maintenance/service contract with the return of this application.
3. Provide a copy of your monitoring agreement with pass codes and passwords redacted. The monitoring agreement must indicate that the alarm is verified before dispatch.
4. Provide a copy of the permit issued by the Moorestown Township Construction Official for installation of the system.
4. Return all of the above in the envelope provided **WITHIN 30 DAYS** of receipt of this notice.

**C. AGREEMENT**

3. allow review and approval of the system, plans, operation and installation by the Enforcing Agency.
